The next meeting of the Parish Plan Committee was on the 4 April at 10.00 at the Neighbourhood Resource Centre. The Public Meeting is to be held at the Resource Centre on the evening of Monday 18 April 2011.

The date for the Parish Fayre had been agreed as 2 July at the Resource Centre. The next meeting of the organising committee is on the 28 March at 6.30 at the Resource Centre.

It was considered that a sum in the order of £1,000 should be set aside for the Parish Fayre.

The implications of closing Canterbury Road on the day were discussed.

Members agreed that the Parish Fayre should be a separate item on the agenda in future.

The bid for grant aid towards the proposed fruit and vegetable market at the Resource Centre was discussed together with potential alternative sources of funding.

41/11 **NEWSLETTER/WEBSITE**

The spring edition of the newsletter would be printed next week ready for distribution before the Easter break.

Members questioned the ownership of the existing Winshill.com domain name and whether a new domain name needed to be established. It was agreed to look into this further and that in the meantime whilst the new website is being set up to “freeze” the existing Parish Council information on Winshill.com.

42/11 **REVIEW OF PLANTING/GROUNDS MAINTENANCE**

It was reported that plants had been purchased ready for planting up the tubs on the 7 April. Volunteers were still required and the “adopt a tub” notices had gone out. There would be a joint flower bed created with Brizlincote Parish on Ashby Road. It was suggested that the Youth Club could adopt a tub on The Level.
