148/14 **PLANNING APPLICATIONS**

The following were reported:

Members discussed the following applications:

P/2014/00863 Additional raised deck area at 4 Mill Hill Lane
P/2014/00906 Erection of a first floor rear extension at 22 Mayfield Road
P/2014/00914 Erection of a single storey side extension at 28 Mount Street
P/2014/00976 Illuminated & non illuminated signage at 192 Hawfield Lane
P/2014/01054 Erection of a detached dwelling to the rear of 16 Rosemount Road

Resolved:

That the Council objects to P/2014/01054 - Erection of a detached dwelling to the rear of 16 Rosemount Road, on the basis that circumstances have significantly changed since the granting of the previous application. Gardens are no longer considered to be brownfield sites and the traffic/parking situation on Scalpcliffe Road has worsened following other recent nearby development. The Council considers that the proposal represents a cramped form of development with minimal amenity space which would be out of character with the general street scene and that the addition of a further property/access would be detrimental to highway safety.

It was also agreed to request that no projecting illuminated signage should be installed above ground level in respect of P/2014/00976.

149/14 **YOUTH SERVICES**

There was a lengthy debate regarding the future of Winshill Youth Centre and of the future provision for youth services in Winshill by the County Council. The County Councillor understood that the Youth Centre was to be sold following a consultation exercise in other areas of the county. The Parish Councillors took issue with this and asked that the moneys from the sale be made available to fund future youth provision in Winshill. They believed that the need for this had been well demonstrated. It was suggested that the new Neighbourhood Resource Centre Charitable Trust should make a bid for funding to support some future provision.

150/14 **COUNTY COUNCILLOR'S REPORT**

The County Councillor confirmed that Library Services were out to consultation but no change would be made to Burton Library with Archive Services being relocated there.

151/14 **BOROUGH COUNCILLORS' REPORT**

There was nothing new to report.

152/14 **MANAGEMENT AND RUNNING OF THE NEIGHBOURHOOD RESOURCE CENTRE**

The Centre had been awarded charitable status with the first meeting of the trustees planned for Wednesday 3 September 2014.

It was reported that the luncheon club was due to start at the end of September and that there were forthcoming Macmillan fundraising and mind, body and spirit events. The new emergency lighting and magnetic door locks had been fitted.

It was suggested that this become the Community Fayre in 2015.

Councillor Perry would report back to a meeting of the working group on progress in September 2014.

Items were required for the next edition of the newsletter in October.

157/14 **REVIEW OF PLANTING/GROUNDS MAINTENANCE**

The Lenghtsman gave an update on his work and in particular the perennial problem of overgrown hedges. It was agreed that these are primarily a problem for the Highway Authority to respond to and to draw up a list/take photographs of the offending locations. Other matters reported were the damage to a tub on Empire Road, litter bins not being emptied and shrubs stolen from planters in East Street. It was suggested that the public could be invited to report known problems in a newsletter article.

It was agreed that Councillors D and M Fletcher together with K Smith attend the Heart of England in Bloom presentation evening taking place on 11 September 2014 at Shrewsbury. The Winhill in Bloom awards evening will be taking place on 18 September 2014 at the Resource Centre.

Reference was made to a project Paul Steed from the Horticultural Centre was undertaking at the bottom of Bearwood Hill funded by the Prince's Trust and a recent showing of the Peace Wood on the forces TV channel (Sky). The Peace Wood is due to be officially opened on 17 November 2014 with an exhibition also taking place at the Resource Centre.

It was reported that the Open Gardens Sunday had been a success thanks largely to the work of Councillor Perry in organising the event.

Resolved:

That a buffet be provided for the Winhill in Bloom awards evening within a budget of £200.

158/14 **PARISH YOUTH COUNCIL**

It was reported that the cost of a team building event in the autumn of 2014 at Alton Towers would cost in the region of £536 for 16 children and 4 adults plus transport costs. It was agreed that this was a matter for the Youth Council to discuss further. All the necessary DBS checks had been completed.
