76/17 **PLANNING APPLICATIONS**

The following planning applications were reported:

P/2017/002564 – Erection of a 2 storey rear extension at 3 Cherry Lees

Members decided to raise no objections to any of the above.

77/17 **BOROUGH COUNCILLORS' REPORT**

The Borough Council was in the process of testing the market with regards to the running of the leisure centres, market hall and Brewhouse. It was also considering landlord licencing and the sale of Pennycroft Lane in Uttoxeter.

78/17 **COUNTY COUNCILLOR'S REPORT**

The County Councillor referred to the recent resurfacing works on Ashby Road and line marking at the Swan Junction with the latter needing to be reconsidered. He had £7,000 to be spent on potential highway projects at Empire Road (one-way system), Alexandra Road (one-way system) and improvements to parking/traffic flow along The Level with the Parish Council supporting the latter of these projects. He reported that the parking orders along Hawfield Lane were ready to be implemented whilst the transport impact assessment for the potential Sales Lane development needs to be done again.

79/17 **NEIGHBOURHOOD RESOURCE CENTRE CO-ORDINATOR'S REPORT**

It was reported that the Centre was fully booked most evenings and the Luncheon Club was proving very popular. The CAB were as busy as ever with the service needing to be reviewed as soon as possible. Arrangements were well in hand for the Parish Fayre on 29th May 2017.

80/17 **NEIGHBOURHOOD PLAN**

The Clerk reported that he had finally reworked all the documentation and considered the comments received from the statutory consultation. This has now been sent to the Borough Council in order for them to undertake the Regulation 16 consultation exercise before referring the Plan to a Government Inspector.

81/17 **NEWSLETTER/WEBSITE**

It was agreed to discuss the report presented on the Information and Publicity Policy at the next meeting. It was also agreed to delay the Summer edition of the Newsletter in the light of this discussion.

82/17 **REVIEW OF PLANTING/GROUNDS MAINTENANCE**

The date set for the Heart of England in Bloom judging was the 11th of July 2017. This would take all day due to the addition of the Peace Wood and Tower View School in separate categories. The Winshill in Bloom judging will follow on the 17th July 2017. An initial estimate of around £8,000 for the hard landscaping as part of the Peace Wood Memorial had been given by Idverde with the hope that this could be largely grant aided.
