Minutes of the Meeting of the Winshill Parish Council held at Winshill Neighbourhood Resource Centre at 7.30 pm on Thursday 28th January 2016.

MATTERS RAISED IN PUBLIC PARTICIPATION

There were no members of the public present.

1/16 DECLARATIONS OF INTEREST

There were no declarations of interest made.

2/16 MINUTES

The Minutes of the Meeting held on 17th December 2015 were agreed and signed as correct records of events.

3/16 CORRESPONDENCE

P/2015/01070 Outline for the erection of a dwelling and replacement garage at 95 Newton Road

Resolved:

That it be a condition of any approval that there is no obstruction of the public highway with regards to the construction of the additional dwelling at 95 Newton Road (P/2015/01070) in view of the restricted plot close to a bend/hill on the busy B5008 in the interests of both the free flow of traffic and public safety.

5/16 **YOUTH SERVICES**

The County Councillor advised that there was nothing new to report and it was agreed that this item be dropped from future agendas.

6/16 **COUNTY COUNCILLORS' REPORT**

The County Councillor reported that the drain clearing had recently been carried out. He agreed to look into the problem on Bearwood Hill Road near to the nursing home. He was pushing for an initiative to provide more sports facilities in Winshill and in particular a sports hall at Abbot Beyne School. This was supported by the Parish Council members and was specifically referred to in the Draft Neighbourhood Plan.

He explained that money from the highway budget was being reduced due to the increased demands of social care – an area where changes were needed in conjunction with the Health Service. The County Council rates were likely to go up by 3.95% as a result of cuts by in Central Government funding.

7/16 **BOROUGH COUNCILLOR'S REPORT**

Councillor Faulkner reported that the proposals submitted to the Neighbourhood Forum including the proposed garden of reconciliation, the scheme to tidy up the frontage of Newton Road Recreation Ground had been approved but the siting of outdoor gymnasium equipment on Canterbury Road play area had not been successful. He was looking into the concerns of a resident of Alexandra Road regarding the ongoing problem of parent parking outside Holy Rosary School despite permission given to use the Ashfield House car park.

The Borough Council would not be increasing its rates for 2016/17.

8/16 **NEIGHBOURHOOD RESOURCE CENTRE CO-ORDINATORS REPORT**

The Administrator reported that there were plenty of party bookings as well as a new dance class and the Jubilee Church using the premises. It was reported that the CAB had been very busy since Christmas. The Chairman agreed to ask the CAB for an update.

9/16 **PARISH PLAN**

There was nothing new to report.

10/16 **COMMUNITY/ PARISH FAYRE**

Councillor O'Mahoney reported that the organising committee had now booked the DJ, Magical

Mahem, Touch of Life Dance Group, Wishes for Winshill (to provide refreshments) and some different inflatables for Monday 30th May 2016. A road closure would be required again together with volunteers to supervise some of the inflatables.

11/16 **NEIGHBOURHOOD PLAN**

It was agreed that the consultant be asked to submit it together with the Consultation Statement to the Borough as required under the Section 16 Regulations on behalf of the Parish Council. Following any amendments considered necessary following their final check it was then hoped that they will be able to arrange for the independent examination to proceed at an early date.

Resolved:

That the revised Neighbourhood Plan is approved and that it is moved towards final adoption ASAP.

12/16 **NEWSLETTER/WEBSITE**

The idea of a Winshill resident to set up a website offering advice and a forum for IT advice with no charge involved was considered by the members to be a good idea in principle and it was suggested that he could attend a future meeting if he wished to discuss matters further.

13/16 **REVIEW OF PLANTING/GROUNDS MAINTENANCE**

There was nothing new to report.

14/16 **PARISH YOUTH COUNCIL**

A date for the next meeting of the Youth Council needs to be arranged ASAP to discuss the commissioning of the play equipment on Wheatley Lane.

16/16 **GRANTS TO OTHER ORGANISATIONS**
